

# **About the programme:**



What area of law will I work in?

You will work across all of our teams during your summer with Corcoran French. In no particular order your time will be divided into four blocks:

Christchurch Commercial. During this time you will receive exposure to the day to day running of our commercial law team which could involve property, contract law, trusts or estate work.

Litigation. You may attend court with our litigators (it depends on scheduled court appearances) and get real hands on experience with the workings of dispute resolution and litigation.

Kaiapoi Commercial & Estates. Based in our Kaiapoi office, you'll do similar work to what you will have done with our Christchurch commercial team. You'll also spend time working in our Kaiapoi estates team.

Family. You'll receive exposure to the range of family law matters that the team deal with, including relationship property, care of children, family violence and dissolutions.



## Will I have client contact?

Absolutely. We think it is important for you to have client contact and wherever there is an appropriate opportunity you will be included, alongside one of our experienced lawyers.

### 3 What hours will I work?

You will work a standard full-time working week. Our expectation is that you will have a strong work/life balance while working at Corcoran French. Obviously you will work hard at work but don't expect to be working late into the night.



#### 4 Will I be paid?

Yes! You will be paid a market wage. You will also still be paid during our close down period over Christmas.

## Who is Corcoran French looking for?

## 6 Who will look after me during my summer clerkship?

We have buddies in each of our teams who will look after you on a day to day basis. Your buddy will act as your mentor while in their team and they will be able to answer all the questions that you have and give you guidance on a day to day basis. #### What dates will my summer clerkship begin and end?

We are flexible about this and can work around you. We anticipate mid-November to mid-February with around three weeks off during the Christmas break. We'll finalise these dates closer to the time and we'll even pay you during the Christmas break so that you can relax and enjoy your summer holiday!



#### 8 What is the application process and how do I apply?

Our applications open on Tuesday 4 March 2025 and close at 5pm on Thursday 27 March 2025. We plan to interview in late April, early May and offers will be made shortly after.
